

## Release for Participation in Rising Tide Swim Camps

For the purposes of this document, herein after referred to as “**Release,**” the party intending to participate in the activity in the University Department of Athletics facilities shall hereafter be referred to as “**Participant.**” Rising Tide Swim Camps, the University of Alabama, and its trustees, officers, employees and agents, acting within the course and scope of their duties, shall hereafter be referred to as “**University.**” The activity in the University of Alabama facilities that the Participant will participate in shall hereafter be referred to as the “**Activity.**”

### Description of Activity: Rising Tide Swim Camps

**1. Release, Waiver of Liability, and Assumption of Risk:** In consideration of the opportunity afforded Participant to participate in the Activity in the University facilities, Participant hereby releases and forever discharges the University from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from or in connection with the Activity. Participant understands that this Release discharges the University from any liability or claim that Participant may have against the University with respect to any bodily injury, personal injury, illness, death, property loss, or property damage that may result from participation in the Activity. Participant understands and acknowledges that potential risks to health and personal property may be associated with participation in the Activity, and Participant voluntarily assumes those risks.

**2. Medical Treatment and Preexisting Medical Conditions:** Participant hereby grants permission for physicians, dentists, other licensed health care providers and their designees to administer medical, surgical, or dental services as appropriate, or necessary antigens or other injections, to perform emergency procedures as necessary or to refer to duly licensed medical personnel when indicated. Participant hereby releases and forever discharges the University from any liabilities, claims, costs and damages that arise or may hereafter arise on account of any first aid, medical treatment, or service rendered to Participant in connection with the Activity. Participant will take for herself or himself any appropriate precautions or medications to treat and/or reduce the likelihood of exacerbating any pre-existing health conditions, or insect, food or medication allergies.

**3. NCAA Compliance:** By signing below, Participant acknowledges that they have not knowingly participated in or become aware of any violation(s) of NCAA rules involving the University or individuals affiliated with or acting on behalf of the University. Participant’s signature below also indicates Participant’s agreement to immediately disclose to the Department of Athletics Compliance Office any NCAA rules violation(s) of which Participant becomes aware.

**4. Other:** This Release shall be binding and legally enforceable against Participant and Participant’s heirs, executors, administrators, and legal representatives. This Release shall be governed by and interpreted in accordance with the laws of the State of Alabama. In the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release.

# Rising Tide Swim Camps Code of Conduct

---

- 1. The use of alcohol, drugs, tobacco, and any other illegal or inappropriate substance by campers is prohibited.** Violations will be considered justification for immediate expulsion from the Camp without refund.
2. Campers are not allowed to bring weapons or any other inappropriate items to camp. Any items found will be confiscated and calls to parents made.
3. Inappropriate language will not be tolerated.
4. Campers are expected to follow the rules set forth at the camp director's meeting on the first evening.
- 6. Campers are not permitted in rooms or suites occupied by people of the opposite sex at any time. Violation will result in expulsion from camp without refund.**
7. A curfew procedure will be explained to the campers at an orientation meeting on the first day of Camp. It will be enforced without exception. Absence from their room at bed check or the dorm without supervision of a staff member is a serious matter and will be handled by the Director.
8. As a courtesy to fellow campers and to other residents, loud and boisterous activity must be minimized. Quiet hours will be established and enforced. Campers are allowed only on the swim camp floors. All other floors, except common dorm areas, i.e., first floor lobby, game room, etc. are off limits. The camp floors are off limits to non-camp residents. Parents and visitors are not allowed beyond the first floor lobby (i.e. in the camper's room).
9. Campers must keep their rooms clean and in good order. Campers and their parents will be held responsible for any damage to rooms and furnishings, and payment for such damage will be billed to the parents. In cases where damage is incurred by a group, the person(s) directly involved along with each member of the group will be responsible for an equal portion of the damage. Campers should report any problems to their counselors.
10. Campers themselves may not have use of automobiles while they are at the Camp nor may they ride in any vehicle other than the designated camp vehicles.
11. Campers are expected to dress sensibly and appropriately at all times. Shirts, shorts, and shoes must be worn at the natatorium, on all walks and activities, and in and around the dorm.
12. Campers are expected to show courtesy toward fellow campers, recreational swimmers and staff at the natatorium, the dorm staff, and the Camp staff.
13. Campers are required to attend all camp sessions and be on time for roll call. If a camper is ill they should contact a counselor or trainer immediately.
14. If a camper's behavior is consistently and severely at odds with the Camp's rules and regulations, he/she will be sent home. Parents will be notified and required to make all necessary transportation arrangements for an immediate return home at their expense. There will be no refunds or credit of fees from the Camp under these circumstances.
15. Theft and vandalism will not be tolerated. We are guests at the University of Alabama and all University property must be treated with respect. Rising Tide Swim Camps LLC will not be liable for any lost, stolen, or damaged property. Any valuables brought to camp are assumed responsibility of the camper.

**I understand the above rules, and agree to follow additional rules explained to me when I arrive at camp. I understand that violation of the Camp's rules and regulations can result in my immediate expulsion from camp without refund.**
